



Virginia K. Saba Nursing Informatics Leadership Award

PURPOSE

The Virginia K. Saba Nursing Informatics Leadership Award honors an individual for his or her innovative and cutting-edge work in the field of nursing informatics. The individual's work must have resulted in a significant development and sustained contributions to advance the discipline of nursing informatics. The individual's work also must achieve a recognizable and momentous public benefit.

This award will be presented during the Sigma Theta Tau International biennial convention, and the recipient will be invited to present an abbreviated presentation of his or her work during a concurrent session. A \$500 stipend and a commemorative award will be given to the recipient, and his or her travel and convention registration will be funded by the Foundation.

The award will become permanently endowed and offer a notable stipend in the future through Dr. Saba's planned gift to the Sigma Theta Tau International Foundation for Nursing. Donors may contribute directly to this award by contacting the Foundation for Nursing.

CRITERIA

- The nominee is a nurse and a member of Sigma Theta Tau International. (Honorary members are eligible).
- The individual's work is considered a major development or breakthrough in nursing informatics that has sustained a notable and historic impact on the health care industry.
- The individual's accomplishments include being a consultant in the field of nursing informatics or a leader of a prominent health care institution, university, business, or other health care setting.
- The individual is recognized as an informatics expert whose contributions have the capacity and scope to enhance quality, safety, outcomes and decision making in health and nursing care from a national or an international perspective.

JUDGING

Judges will include a committee of honor society members appointed by Sigma Theta Tau International, members of nursing informatics specialty groups and past recipients.

SUBMISSION REQUIREMENTS

A complete nomination consists of:

- Online entry form
- 500-700 word support summary that addresses criteria from the nominator
- Three diverse letters of support that address criteria
- Nominee's curriculum vitae
- Any other supporting material (not to exceed ten pages) that provides direct evidence of the sustained leadership in the contribution to nursing informatics for which the nominee is being recognized
