PURPOSE

The Chapter Communications and Publicity Award recognizes chapters that have exceptional chapter communication and publicity efforts. ELIGIBILITY

All active chapters of STTI are eligible for this award and are encouraged to apply. This award recognizes chapter communication and publicity efforts from 1 March 2015 through 1 March 2017.

NOMINATIONS

Any chapter member or officer may nominate.

CRITERIA

- Uses various media web, print, electronic to communicate with various audiences — chapter members, campus community, local community
- Communications serve various purposes educating people about the chapter and STTI's history, promoting membership, and publicizing activities and opportunities
- Communicates information at appropriate times
- Updates chapter website accordingly
- Distributes relevant information to members, campus community, and local community to enhance the chapter's visibility, initiatives, and activities within those groups
- Creates unique ways to communicate appealing layout and design of the chapter's web, print, and electronic communications

SUBMISSION REQUIREMENTS

Supporting documents required below must address the criteria. A complete online nomination consists of:

- Online entry form and payment
- Supporting narrative (1-2 pages)
- Any other supporting documentation to include, but are not limited to, fliers, newsletters and website pages that demonstrate implementation of communication efforts (not to exceed 10 pages)
- Letter of acceptance
