Founders Awards

Edith Moore Copeland Award for Excellence in Creativity

PURPOSE

The Founders Awards offer homage to the six founding nurses of STTI and the director of nursing at Indiana University for their insights in 1922 that advanced scholarship, leadership, research, and practice. The awards recognize extraordinary excellence.

ELIGIBILITY

Nominee must be an active member of Sigma Theta Tau International. STTI Board of Directors, STTI staff, STTI consultants and contracted staff, and members of the judging committee are not eligible.

NOMINATIONS

Two active members or a chapter are required to nominate an individual.

CRITERIA

- Demonstrates creative activity to impact nursing education, practice, or research
- · Advances the knowledge base of nursing through creative activity
 - o Presents a creative view of nursing
 - Participates in creative activity that serves as a stimulus for research, practice, and education
- Impacts the image of nursing through creative activity
- · Communicates results of creative activity
 - Publications
 - o Presentations (workshops, lectures, etc.)
 - o Non-print media
- Fosters creativity in people such as colleagues, students, clients, and other healthcare providers
- Receives recognition for creative activity
 - o Awards
 - o Citations
 - o Honors
- Is involved in other contributions that indicate creativity

SUBMISSION REQUIREMENTS

Supporting documents required below must address the criteria. A complete online nomination consists of:

- Online entry form and payment
- Supporting narrative (1-2 pages)
- Three (3) letters of support from national and global leaders internal and external to nursing
- Nominee's curriculum vitae
- · Letter of acceptance
