# Virginia K. Saba Nursing Informatics Leadership Award

#### **PURPOSE**

The Virginia K. Saba Nursing Informatics Leadership Award honors an individual for his or her innovative and cutting-edge work in the field of nursing informatics. The individual's work must have resulted in a significant development and sustained contributions to advance the discipline of nursing informatics. The individual's work also must achieve a recognizable and momentous public benefit.

This award will be presented during STTI's biennial convention, and the recipient will be invited to present an abbreviated presentation of his or her work during a concurrent session. A US \$500 stipend and a commemorative award will be given to the recipient.

The award will become permanently endowed and offer a notable stipend in the future through Dr. Saba's planned gift to the Sigma Theta Tau International Foundation for Nursing. Donors may contribute directly to this award by contacting the Foundation for Nursing.

#### **ELIGIBILITY**

Nominee must be an active member of Sigma Theta Tau International (members may not self-nominate). STTI Board of Directors, STTI staff, STTI consultants and contracted staff, and members of the judging committee are not eligible.

# **CRITERIA**

- The nominee has made contributions during his or her professional career in the field of nursing informatics and has had a sustained, notable and historic impact on the healthcare industry, education, and/or research.
- The nominee has had a major impact or participated in a significant or major breakthrough in the field of informatics.
- The nominee has served as the nursing informatics leader in a prominent healthcare institution, university, business, or other healthcare setting or served as a consultant in the field.
- The nominee is a recognized informatics expert whose work has had the capacity and scope to enhance quality, safety, outcomes, and decision making.
- The nominee is an established leader in the field of informatics related to nursing and health from a national and international perspective.

# **SUBMISSION REQUIREMENTS**

Supporting documents required below must address the criteria. A complete online nomination consists of:

- Online entry form and payment
- Supporting narrative (1-2 pages)
- Three (3) letters of support from diverse sources
- Letter of acceptance
- Nominee's curriculum vitae
- Any other supporting documentation that provides direct evidence of the sustained leadership in contribution to nursing informatics for which the nominee is being recognized (not to exceed 10 pages)
